REGISTRATION FOR STUDENT PARKING 2019-2020 School Year

Attention Students and Parents,

As our school population continues to expand, we remain committed to providing a parking space for all seniors in good standing. Our goal for student drivers is to ensure a safe environment. In support of that goal **WE REQUIRE THAT EVERY STUDENT MUST ATTEND A SAFE DRIVING SEMINAR AND HAVE A PARKING PERMIT BEFORE PARKING ON CAMPUS.**

Safe Driving Seminars are conducted in conjunction with the Webster Central Chemical Abuse Prevention Team and provide an overview of New York State driving laws and safety guidelines. **Seniors**, if you plan on driving to school in September, attendance at the August Safe Driving Seminar is **mandatory**. Students **MUST** attend a Safe Driving Seminar each school year. Seniors who anticipate applying for a parking permit are encouraged to attend a driving seminar prior to submitting their application. Seniors who submit completed paperwork and are approved will be issued their parking permit at the end of the driving seminar.

Juniors will be invited to the September (and future) driving seminars only. After completing the Safe Driving Seminar and submission of completed paperwork, Juniors will be placed on a list for a lottery drawing. Parking permits will be issued to Juniors whose names are drawn by administration starting November 1, 2019. **Due to space constraints, there is no guarantee that juniors will receive a parking permit.**

Attached is the application to park at Thomas High School. Additional copies can be found on our school's website as well as in the Thomas Main Office. The application includes a full description of the regulations for parking at Thomas High School and some of the common infractions that we encounter on a regular basis. Review the material carefully. Incomplete applications will be returned and therefore delay issuance of a parking permit.

We are very serious about providing all students and staff a safe parking environment. **Consequently, any violation of the rules outlined on the attached parking application will result in the loss of parking privileges. Students who have their student parking permit revoked for any reason MUST attend another Safe Driving Seminar before reissuance of their permit will be considered.**

Please read the attached regulations carefully. Students and parents must sign the application to acknowledge understanding of the rules for parking at Thomas High School and the consequences for not following those rules.

Seminar and registration will be held at Thomas High School Auditorium on the dates/times below. Please note that the summer registration dates have been assigned alphabetically. Students are urged to register on their designated date and time to help expedite the process.

Students must bring the completed registration application form signed by a parent or guardian, along with copies of their driver's license and vehicle registration(s), to the driving seminar session. Seniors must have a valid parking permit to park on campus at the start of school.

PARKING REGULATIONS**

Please read carefully, keeping your parking pass depends on it!

As an applicant for a parking space, I acknowledge that driving to school and parking on school grounds is a privilege that can be revoked. Please note that duplication of parking permits for any reason is strictly prohibited. In submitting my application for a parking permit, I agree that I will:

- ◆ Refrain from all forms of reckless driving including: excessive speed, carrying students on hood, top or trunk of vehicle (Any reckless act will be reviewed by the administration and may result in immediate and long-term loss of parking privileges)
- ◆ NOT USE A CELL PHONE OR TEXT WHILE DRIVING ON SCHOOL PROPERTY.
- ◆ Obey all traffic signs and directions of parking supervisor(s).
- ◆ Parking permits are only valid for the assigned individual and their registered vehicles.
- ◆ Not lend other students my car during the school day.
- ◆ Arrive at school and/or class on time/day and agree not to be late more than three (3) times during a marking period.

PARKING REGULATIONS CONTINUED:

- ◆ Leave school only with permission during the school day.
- ◆ Not take students off campus during the school day.
- ◆ Not Drive to Monroe #1 BOCES Campus (EMCC). **Prior BOCES approval and parental consent is REQUIRED.**
- ◆ Not park in unauthorized areas. Prohibited from parking on the Willink campus during the school day.
- ◆ Not smoke or have tobacco in possession either on my person or in my car.
- ◆ Not litter
- ◆ Not Play the car radio at an unreasonable level.
- ◆ Correctly display the parking tag or other authorization pass provided by the school.
- ◆ Report all accidents to appropriate authorities.
- ◆ Not go to my vehicle between or during classes or lunch without authorization.

Any violation of the above regulations or the Webster Central School District Student Code of Conduct will result in the following:

1st offense: Loss of parking privileges on campus for a minimum of 2 weeks. Student must attend another driving seminar.

2nd offense: Depending on the nature of the offense, loss of parking privileges on campus for a minimum of 1 month. Student must attend another driving seminar.

3rd offense: Depending on the nature of the offense, a possible loss of parking privileges on campus for a full year. Student must attend another driving seminar.

I acknowledge that given reasonable cause, school authorities may search my car with an administrator, and/or police with me present.

Any violation of this contract may result in suspension of driving privileges at the discretion of the Assistant Principal or Principal.

PARKING ON SCHOOL GROUNDS WITHOUT PERMISSION AND/OR FAILURE TO COMPLY WITH ANY OF THE ABOVE WILL RESULT IN LOSS OF PARKING PRIVILEGES AND/OR ADDITIONAL MEASURES AS DETERMINED BY THE CIRCUMSTANCES (i.e. Towing at Owner's Expense)

I will report lost or stolen tags to the Parking Supervisor(s).

We have read this completed application, including the regulations, and agree to abide by all such rules. We also understand that if the parking privilege is granted, abuse of the parking privilege WILL result in revocation of the permit and/or towing the car at the owner's expense.
