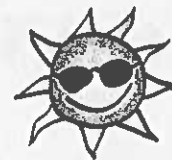


2025 SENIOR TRIP

2025 SENIOR TRIP

DATES:

- Tuesday, June 10 – Thursday, June 12, 2025
- Buses leave Schroeder on Tuesday morning around 9:00 a.m. after our breakfast and loading of the buses - ***students must take the bus to and from Camp Cory. Any students who drive to Schroeder may leave their vehicles in a supervised lot during the trip.***
- We will arrive back at Schroeder around noon on Thursday.

ACCOMMODATIONS:

- Most cabins sleep 10 people. A limited number of cabins sleep 12 people.
- Each cabin has electricity, lights, bunk beds, mattresses, screened-in windows, and a ceiling fan.
- Linens are not provided. *Students are responsible for bringing their own bedding and towels.*
- Bathrooms and showers are conveniently located.

DINING:

- All meals will take place in Camp Cory's dining hall. Beverages will be available in the dining hall throughout the trip.
- If you have dietary restrictions, please indicate this on the student/parent contract so that we can make the proper arrangements.
- Only unopened packaged goods can be brought on the bus. Be sure to place snacks in storage containers so that they do not attract pests.
- NO beverages/liquids or home-prepared foods are allowed.

ALL PAPERWORK AND PAYMENT NEEDS TO BE SUBMITTED BEFORE YOUR SPOT IS RESERVED.

If you need to cancel your spot on the trip, refunds can be given through Friday, May 9th. After that date, we will be unable to refund your payment.

In order to reserve your spot, you must submit the following on or before Friday, April 25:

- Cash or check payment of \$160.00
- Senior Trip Student/Parent Contract
- Overnight Field Trip Emergency Medical Information
- Overnight Field Trip Medication Orders
- Cabin Roommates form – ONE form per cabin.

If applicable:

- Bring medications NOT approved for self-carry to the Health Office by May 27.

2025 SENIOR TRIP RULES & CONSEQUENCES

TRIP ELIGIBILITY

- In order to be eligible to attend senior trip, seniors must:
 - be passing and in a position to graduate.
 - have at least a 85% attendance rate.
 - have no high-level discipline (suspension) incidents.
 - Some students may be asked to sign an agreement in order to be eligible based on the above requirements.
 - Building administration reserves the right to deny access to this trip based on an individual student's behavioral record, attendance, or grades.

RULES

- The Webster Central School District code of conduct applies.
- Absolutely **NO ALCOHOL, TOBACCO, VAPORIZERS, OR CONTROLLED SUBSTANCES**
- Beverages/liquids or home-prepared foods are NOT allowed. Only unopened packaged goods are allowed. *Beverages will be provided!*
- No unsupervised water activities - water safety rules are strictly enforced.
- Respect camp quiet hours of 10 p.m. - 6 a.m.
- No co-ed sleeping arrangements.
- Respect Camp Cory's equipment - anything broken or lost is our responsibility to repair or replace. All cabin members share the responsibility for any damage.
- Only parents can drop off/pick up students from the camp. If you need to arrive late or leave early, please indicate this on the student/parent contract so that we can plan accordingly.
- COVID protocols will be based on Monroe County Health Guidelines at the time of the trip

CONSEQUENCES

- If a student breaks any of the trip rules, parents will be called and will be expected to pick their child up.
- Should illegal substances be involved, police will be contacted and will provide parents with directions and student retrieval procedures.
- Serious violation of the rules will result in a suspension from school and a referral to a Superintendent's Hearing for a long-term suspension through graduation.

2025 SENIOR TRIP MEDICATIONS

- ALL students **MUST** complete the Overnight Field Trip Emergency Medical Information and the Overnight Field Trip Medication Orders.
- WCSD's physician has ordered some over-the-counter (OTC) medications to be available to students as needed on the trip. Circle the medications you authorize school staff to administer as needed on the Overnight Field Trip Emergency Medical Information.
- If a student requires OTC or prescription medications other than district authorized medications:
 - Medications must be listed on the Overnight Field Trip Medication Orders.
 - Medication must be clearly labeled in the Rx bottle or manufacturer's container.
 - Bring only the amount needed for the trip, with the exception of oral contraceptives.
 - Approved self-carry medication may be packed in your luggage.
 - Chaperones are not responsible for assuring that students administer their self-carry medications.
 - Any medication that is NOT approved by a doctor to be self-carried must be submitted to the Health Office by May 27th.

MEDICATION GUIDELINES FOR OVERNIGHT FIELD TRIPS OFFERING OVER-THE-COUNTER (OTC) MEDICATIONS ORDERED BY THE DISTRICT MD

1. WCSD's physician has ordered the following OTC medications to be available for students as needed on the trip:
 - **Acetaminophen** (Tylenol) 500-650 mg every 6 hours as needed for pain or fever
 - **Ibuprofen** (Motrin/Advil) 200-600 mg every 4-6 hours as needed for pain or fever
 - **Meclizine** (Bonine/Non-drowsy Dramamine) 25-50 mg every 12 hours as needed for motion sickness
 - **Cough drops** (Halls/Fruit Breezers) 1 lozenge every 2 hours as needed for cough or sore throat
 - **Antacid** (Tums) 500-750 mg 3-6 times daily as needed for upset stomach
 - **Loperamide** (Imodium) 1 tablet every 8 hours as needed for diarrhea
2. **Circle the medications you authorize school staff to administer to your child, as needed, on the trip on the Overnight Field Trip Emergency Medical Information.**
3. A parent/guardian does not need to provide the medication or obtain a separate medication order from the student's physician if it is circled on this form.
4. The medication chaperone carries these medications and will administer only authorized medications to students who request them.
5. The school provides the medication in generic pill form. If your child does not swallow pills, a parent must provide the chewable or liquid medication and submit the **Overnight Field Trip Medication Orders**.

OTHER OTC MEDICATIONS AND ALL PRESCRIPTION MEDICATIONS

If a student requires the administration of other OTC or any prescription medications on the trip:

1. Written health care provider medication orders and written parent/guardian authorization are required for all medications, including OTCs.
2. Students may independently carry and use medications only if the student's physician, parent, administrators, and school nurse are in agreement and Independent Carry and Use medication orders have been provided to the nurse on the **Overnight Field Trip Medication Order Form** OR are on file in the Health Office for the current school year.
3. The medication must be in the labeled Rx bottle or manufacturer's container and contain **ONLY** the amount needed for the trip.
4. Chaperones are not responsible for assuring that students administer their independent medications.
5. If the medication is not going to be self-carried by the student, it must be submitted by an adult prior to the trip.
6. If unused medication is not returned to the parent by the chaperone when picking up their child after the trip, an adult must pick up this medication from the Health Office within two weeks of the trip or it will be discarded.
