Dear Families,

You are receiving this letter because our records indicate that you are the parent/guardian of a student with a disability, and you have selected to educate your student in a private/parochial school or are home-schooling your student.

If you plan on continuing or beginning enrollment in a private/parochial school, or home-schooling your student with a disability, and you wish for your student to receive special education services for the upcoming 2026-2027 school year, you MUST send an email with your request to Webstercsdstudentservices@webstercsd.org or return the included request form by June 1, 2026. This request to the public school district is required under New York State law. You must make this request annually while your student is enrolled in a private/parochial school or home-schooling.

If you plan on enrolling your student with a disability in a private/parochial school outside the geographic borders of the Webster Central School District, you must inform the district of the private school's location by June 1, 2026 that you wish to receive special education services for the upcoming school year.

If you plan on re-enrolling your student in a public school district or charter school, you do not need to send an email or return this form. Your student will receive special education services when enrolled in a public school or charter school without this request.
